Case Summary:

Support vessel within starting area.

Procedural Matters: -

ITA 2101757 and ITA 218559 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).

Competitors supported by Denis KHASHINA who attended the hearing are: UKR 217791, UKR 202435. Competitors supported by Denis KHASHINA who did not attend the hearing are: ITA 210757, ITA 218559.

Facts Found:

- 1. The incident happened on race course B on 19.11.2022.
- 2. After the starting signal of the ILCA 6 men a general recall was displayed.
- 3. Support vessel with registration nr. 92 was observed to be less than 50m away from the starboard end starting line mark.
- 4. Support person with support vessel registration 92 is Denis KHASHINA.
- 5. Denis KHASHINA apologized for his action.

Conclusion & Rules: -

- 1. By not staying outside the starting area as required by SI D5.1.2, as amended in Amendment 2, Denis KHASHINA broke SI 23.1.
- 2. Using the Discretionary Penalty Policy, a starting penalty of Band 3 was decided.
- 3. The penalty was decreased because the competitors supported by Denish KHASHINA are less than 18 years old and Denis KHASHINA apologized.

Decision:

- 1. Denis KHASHINA is penalized under 64.5(a)(3) as follows: his support vessel shall be anchored outside the starting area while the race committee vessel is anchored until all boats of the ILCA 6 men fleet have finished race 6.
- 2. UKR 217791, UKR 202435, ITA 210757, ITA 218559 are warned under RRS 64.5(b)(2) that a penalty may be imposed if Denis KHASHINA commits a further breach of any rule.

Short Decision: Decision Date Decision Time

Denis KHASHINA to be anchored outside the starting area from the moment the race committee vessel is anchored until all boats of the ILCA 6 men fleet have finished race #6. Supported competitors are warned.
