Case Summary:

Facts Found:

Approaching mark 5,
When USA 217337 reached the zone, she was clear ahead of FRA 218230 and ITA 219773
USA 217337 slowed down close to the mark because of the boats ahead of him were rounding the mark. There were boats to leeward of USA.
ITA 219773 reached the zone, on port clear, ahead of FRA 218230.

FRA 218230, on port, established an inside overlap later, in the zone with a lateral distance of 1 meter between the boats FRA 218230 and ITA 219773.

ITA 219773 bore away to pass behind USA 217337 at mark 5

FRA 218230 continued sailing straight ahead towards mark 5 and USA 217337.
Contact occurred between the bow of FRA 218230 and abeam of the mast of USA 217337, making a 10 cm hole, causing leakage of water.
USA 217337 continued the race and finished with a lot of water in the hull.
No boat took any penalty.

Conclusion & Rules:

FRA 218230 did not give mark-room as required by RRS 18.2 (b)
There was contact between FRA 218230 and USA 217337. FRA 218230 broke RRS 14. USA 217337 could not avoid the contact as there were boats in front of him and to leeward of him.
It was not reasonably possible for USA 217337 the boat sailing within the mark-room to which she was entitled to avoid contact with FRA 218230 when it was clear that FRA 218230 was not giving mark-room. USA 217337 did not break RRS 14.
USA 217337 score has been made worse through no fault of her own through damage caused by FRA 218230 breaking RRS 18.2(b), 14 and 11, therefore she is entitled to redress as per RRS 62.1(b).
